

EXTERNAL PROVIDER ROLE OVERVIEW



The External Provider role is a slimmed-down role created for Providers who need access to MotionMD to review and sign Patient Agreements for only their patients. This role also has a feature that allows Providers to opt into an email notification letting them know there are Patient Agreements ready for signature.

Upon login, if Patient Agreements waiting on signatures, they will be listed on the main dashboard. Click the **Sign All** button.

Once all Patient Agreements have been signed the main dashboard will indicate none are waiting.


